This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

1. The following services are added to contracts based on Open Enrollment #0416-0101, and take effect as of April 01, 2017.
2. The term of this contract is extended an additional year. The new contract end date is June 30, 2019.
3. **Section 4.a.(2)(c), Statement of Work, CRP Services, Trial Work Experience and Community Base Assessment Services** is amended to add the following statement:
  - iii. If a CBA occurs in a private business, the activities of the individual with disabilities who is participating in a skills assessment program (CBA) must not result in an economic advantage for the business.
4. **Section 7, Consideration, sub-section a.(1)** is amended as follows:
  - a. CRP Consideration
    - (1) CRP fees shall be paid according to the CRP Fee Schedule, **Exhibit L**, incorporated into this contract by reference and available on DVR's internet page at:

5. **Section 13. Background Checks, sub-section a.** is amended as follows:
  - a. Prior to performing services under this contract, or having any unsupervised access to DVR customers, the Contractor must obtain a DSHS criminal background check through DVR on form number **09-653 (Rev. 04/2015)** for all personnel, interns, or volunteers who may have unsupervised access to DVR customers.

All other terms and conditions of this Contract remain in full force and effect.
