This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

1. Purpose. The purpose of this Amendment is to extend the period of performance, add Section 13 and revise the Maximum Contract Amount as indicated on page 1 of this Amendment.

Special Terms and Conditions to read as follows:

2. Add Section 13. Amendment to read as follows:

This Contract may be amended to extend the period of performance three (3) times up to one (1) year at a time. Amendments, if any, shall be at the sole discretion of DSHS and contingent upon funding availability.

3. Period of Performance. The period of performance is revised by an additional 12 months, to extend the period of performance through June 30, 2018 as stated on page 1 of this Amendment.

4. Total Maximum Contract Amount: Increase the contract maximum by \$24,000 for a revised Total Maximum Contract Amount of \$72,000.00.

All other terms and conditions of this Contract remain in full force and effect.
